Shaw Road Bridge in Medina County, Ohio Complete

Hammontree was hired by the Medina County Engineer for the replacement of a deficient single span box beam bridge. The new replacement structure is an eighty-three-foot single span concrete box beam superstructure with a composite deck.

This new Shaw Road Bridge (*photo shown right*) is supported on integral abutments. The project also involved realignment of the approach roadway to improve sight distance. An existing roadway culvert was extended to correct a scour issue in addition to roadway and structure design.

Huntingdon Marketplace Stormwater Detention Facility

Morris Knowles, Inc. designed an underground stormwater detention facility for the Huntingdon Marketplace project in North Huntingdon Township, Pennsylvania.

The project utilized MC-4500 ADS StormTech chambers to control approximately 20 acres of runoff. Morris Knowles performed the site design and NPDES "critical stage" on-site inspections to verify the construction was in general conformance to the plans and permit requirements. New Lakeview Drive Storm Sewer in the Village of Lakemore

Hammontree was hired by the Village of Lakemore in Ohio to provide engineering for a new storm sewer on Lakeview Drive. This project involved installing storm sewers and catch basins for an area that frequently experienced flooding after rain storms due to poor drainage conditions.
